
















# New Market Community Center Feasibility Study Presentation

# Project Goals

"To provide the Town with information to further plan for the renovation and reuse of the former school building as an updated community center."





# Process and Report

- 1. Information Gathering existing documents and surveys
- 2. Two in-person meetings with community reps (Feb and March) to identify potential uses
- 3. Investigation of building by team to determine issues
- 4. Prepared assessment of building including code, conditions, building systems, structure, hazardous materials
- 5. Generated schematic options and reviewed at in-person meetings.
- 6. Prepared Scope of Work and Cost Estimates
- 7. Identified potential Funding Sources



### Issues

- 1. Systems outdated and need upgrading
- 2. General maintenance of brick, concrete is needed.
- 3. Bathrooms are out of date
- 4. ADA requirements are not met
- 5. Hazardous materials are minimal but those that exist require abatement.
- 6. Overall appearance feels tired and dated, needs updating
- Mostly a refresh and upgrade, major renovation not needed. Very flexible spaces-




### Potential Uses

- Fitness/Exercise Space
- Kitchen/Cafeteria
- Gym/Event Space
- Exhibit Space First floor hall

- Performing Arts Space, Studio Space, Storage/Rental





# **Phasing Potential**

- 1. Exterior
- 2. First Floor (of two-story portion of building c 1930)
- 3. Second Floor (of two-story portion of building c 1930)
- 4. Gym Addition (added on in 1938)
- 5. Cafeteria/Kitchen Addition (added on in 1958)
- 6. Elevator

Note: Mech, electrical, plumbing upgrades happen at the time of the phase. Overall electrical upgraded in the first phase.



# **Budget Considerations**

FULL REHAB at one time - \$5,575,000 - 6,000,000 \$235/sf

### PHASED REHAB

- 1. Exterior and Site Improvements \$1,447,267
- 2. First Floor of 1930 Two-Story portion \$1,669,525
- 3. Second Floor of 1930 Two-Story portion \$1,998,425
- 4. Gym Addition \$1,737,450
- 5. Cafeteria and Kitchen Addition 1958 \$451,170
- 6. Elevator \$393,250

Total Estimated Cost of Phased Rehab: \$7,697,087



# Funding Sources & Operations

A variety of funding sources are outlined in the report. Here are a few that could be particularly beneficial:

- USDA Rural Development Program. Program items like the senior care, gymnasium, performance hall, education facilities, cooking healthy kitchen make this a very good candidate. A typical loan might be 40 years, 3.5% interest, 55% of project cost.
- USDA Community Food Projects Program. These one-.me grants require a dollar-for-dollar (1:1) match in resources, which can include in-kind support. Depending on how the Community / Healthy Food Kitchen plans to be managed, this can be a very helpful grant.
- The Annie E. Casey Foundation. Grants available to remedy food deserts (commercial kitchen / cooking healthy).
- The Helen S. and Charles G. Patterson Charitable Foundation Trust. The non-profit performing or visual arts, or dance programs would be a particularly good match.



# Funding Sources & Operations

- The building is not listed on the National Register of Historic Places. If it were to be listed, the project could be eligible for 20% Federal credit and 25% State credit which could be syndicated to raise money for the project.
- Several communities with Community Centers were researched including Roanoke, Waynesboro, Winchester and Harrisonburg. Housing a Parks and Rec department in the Community Center is one way communities staff community centers.


