

Town of New Market, VA Call to Artist/Muralist for Downtown Mural Project

Deadline for Entries: June 2nd at 5:00 pm EDT

Project Description/Call to Artists:

The Town of New Market is seeking artist/muralist design submissions to be painted/transplanted onto a wall canvas in downtown New Market. The mural will serve as a landmark and destination within New Market, assisting in long term promotion and support of the downtown revitalization of New Market and attracting visitors to its unique visual depiction of New Market. The intended purpose is that this mural will remain in place for many years to come, as it will be a design that is timeless and eye catching for many locals and travelers to come.

Location and canvas details:

At the corner of Route11/South Congress Street and East Lee Street in New Market Virginia. The Canvas is on the corner building on the South side of East Lee Street with the current business being The Heart of the Valley Thrift. Canvas dimensions:

1. The mural will span from the edge of the first window to the right until the change in building depth before the front door

Vision and Style Requested:

Artists are encouraged submit completed designs that embody creativity and that capture the true beauty and uniqueness that New Market has to offer. The design is open to represent the history of New Market, New Market today or the future of New Market. We are a small town with rich history, heritage, and tradition that is moving forward with times and changes while still remembering our roots. Artists are encouraged and open to submit designs that may show the history as well as the current/future of New Market or a design that may not directly be related to history but represents the New Market community and beauty.

Please be mindful that the submissions are not distracting to motorists. Examples of distracting designs could be improper color combinations, tight patterns that appear to move or vibrate to the human eye, and script font. Consider colorful and vibrant designs/art.

Artist Eligibility and Selection Criteria:

This invitation is extended to all artists age 16 and older regardless of where they live. Artists should be reminded that the art submitted must speak to a large group of people of all ages and be appropriate to display in a public space. Minors must have a legal guardian sign for full rights to use the art. A panel of individuals representing diverse interests and expertise will review submissions and determine final designs. The Town will be responsible for fabrication and installation costs but the artist/muralist is to complete the mural art on the canvas.

Payments:

There is no entry fee. Artists will not be reimbursed for their time or expense for their entry. The artists chosen will be paid for their time at the agreed amount and max amount of time. This agreement will grant The Town of New Market full legal rights to publicly display the art and maintain ownership of the mural. The payment will be distributed in one lump sum upon completion of the mural. A memorandum of understanding will be written by The Town of New Market and must be signed by both the artist/muralist and the Town of New Market. As a part of the artist's submission, we ask that they submit their budget breakdown for the project and payment request, if their project was to be selected and completed.

Entry Procedures:

Each artist may submit up to three (3) designs for consideration by the selection committee.

Proposals will be selected based on the following criteria:

- Overall quality of the artistic design.
- Expression of the project vision.
- High visibility and attractiveness.
- Enhancement of New Market
- Potential to attract tourists and promote the town.
- Other criteria not outlined above may be considered as well.

To apply, please submit the following electronically, via mail, or personal delivery.

- A completed application
- A brief and descriptive explanation of the story the design tells
- Physical artwork to be digitally captured/scanned OR
- One portable flash drive with digital images or digital link to a personal cloud storage service that includes the following files:
 - All digital images should be clearly labeled with name of artist and title of workex: artistfullname_imagename_imagenumber -> savannahfrazier_joyinnewmarket_2.
 - A total of no more than thirty (15) images (five per design) may be submitted.
- Budget breakdown for the project and payment request, if the project was to be selected and completed.

In addition, The Town of New Market reserves the right to accept or reject at any time prior to the commissioning of a work, any, or all proposals; to waive any defect or technicality; and to solicit additional artists.
