#### **MAYOR'S CORNER**

In last month's article I reviewed with you some of the basic statistics regarding our ageing population and the operating costs for our town. In this month's newsletter I want to spend some time bringing you up to date on a few of our major projects. Most of these have been in the planning stage for more than 10 years and will soon come to fruition. Part of the problems for the delay was onset of Covid-19. Ironically, this pandemic has left its financial footprint on each of our projects. As you well know, the cost of materials and labor has skyrocketed due to the temporary suspension of manufacturing during 2020-2021.

The Town has moved forward with construction of a much-needed maintenance building and workshop. As mentioned in past articles, our public works employees have been working in an antiquated, mold infested building that was built decades ago. When we first started to plan for this new facility its estimated cost was around \$500,000.00. With the delay in its construction due to Covid, the cost has risen to over \$800,000.00! The cost of a dozen eggs in 2019 was \$1.40 and now \$3.00. YES, inflation is stifling to our economy!

Another project long past due is the sidewalk along Hwy 211 from Congress Street to the Dollar General Store. This was planned back in 2012 but due to budgetary constraints it was never built. How pedestrians have avoided a loss of life over those years is a miracle in itself. During my first two years on council, we secured a cost sharing grant from VDOT to pay for half of the construction which was estimated to be

around \$450,000.00. Our share (\$225,000.00) has been set aside in our budget since 2021, but VDOT suspended activity during Covid and just gave us the "go-ahead" at the first of this year. It now looks like the total cost could be \$650,000.00. Will VDOT come up with their half of the inflated cost? Time will tell.

The largest and therefore the most expensive project is the water tank. This project has been discussed for at least 10-15 years. Our present tank has been in service since the 1960's and has far exceeded its life expectancy. During Covid we expected the construction cost to be around \$4 million and now we anticipate it to be around \$5-6 million. Not only is it the most expensive, but it is the most needed for the town's survival.

Add the cost of these projects to last month's article reviewing the cost of employees and equipment, then you start to understand the expense of operating even a small town like ours. I haven't even mentioned the Community Center project. I will address that in next month's article. Once again, there is great expense to operate a town and we citizens must pay for it. Proportionately, the more citizens, the less the cost per person.

#### DROUGHT WARNING ADVISORY

Reminder: The Virginia DEQ has declared a drought warning advisory for Shenandoah County, as well as surrounding areas. Please be mindful of water usage to help conserve water.

A drought *warning* advisory indicates a significant drought is imminent and is in effect for the Shenandoah region, which includes Augusta, Rockingham, Shenandoah, Frederick, Page, Warren, and Clarke counties, and for the Northern Virginia Region which includes Fauquier, Loudoun, Prince William, Arlington, and Fairfax counties.

Tips to help conserve water during a drought:

Refrain from cleaning the following:

- Vehicles including motorcycles, RVs, campers, golf carts, etc.
- Houses or other buildings
- Sidewalks, driveways and patios/decks

Reduce watering:

- Reduce lawn watering to 2 times or less per week between the hours of 9:00pm and 10:00am
- Reduce garden/flower bed, to include potted plants, watering only when needed between the hours of 9:00pm and 10:00am Refrain from planting new landscaping/grass

Limit showers to 5-10 minutes per person

Use dishwashers only when full

#### **HEAVY TRASH PICK-UP AUGUST 2024**

The Town's Public Works Crews will be collecting heavy trash items TWO MORE TIMES THIS YEAR (see dates below). This month, they will be out picking up your heavy trash items from Monday, Aug 12th through Friday, Aug 16th. Please place all heavy trash curbside. Crews will not go onto private property to make collections. This service is provided to our residential customers only. Crews will pick up trash by item type during the week and will have all trash picked up by the end of the day on Friday, Aug 16th, 2024. Brush and limbs must be tied in bundles no longer than four feet in length. To ensure removal, all heavy trash should be placed curbside no later than 7:00 am on Friday, Aug 16th, 2024. Due to State laws governing the operation of the Shenandoah County Landfill, the Town is unable to remove old TVs, computers, tires, or hazardous materials such as pesticides, herbicides, paint, paint thinner, etc. For instructions on where to take the aforementioned items, you may call the Shenandoah County Landfill at 540-984-8573. #### NEW MARKET FIRE AND RESCUE NEWS
