MAYOR'S CORNER

In this month's newsletter I was hoping to have information to present to you concerning our plans for the Community Center. However, we have not received the results and recommendations stemming from the 6 month investigation by Frazier and Associates. As you may recall, we received a \$50,000.00 grant to help in our cost to examine the structure of the old school and the feasibility of what programs we could offer our citizens. Our town manager and our community center steering committee is anxiously awaiting Frazier's findings and recommendations.

In the meantime, I would like to report about the public forum that Ryan Homes hosted at the New Market Fire Department on Thursday, August 15th. As you may know, they are very interested in developing a residential subdivision on a 100 acre tract of land located on the south side of Click's Lane. Displayed at their forum was a rendering of the subdivision's proposed roads and green space for walking trails. Pictures were also presented of the homes to be built and the size of the lots that would be available. I was very pleased with

the turnout by our citizens, town council and planning board members. Many citizens' concerns were answered by Ryan's representatives and constructive suggestions were expressed by those same attendees. I look forward to a final product that pleases our citizens and the developer.

One of the valid concerns that citizens have expressed is the increased traffic flow on Click's Lane that will result from the new subdivision. Ultimately this will be VDOT's decision. Once the developer finalizes the number of homes that they would like to build, then VDOT will do a traffic analysis study and place requirements on the developer to improve traffic flow. As it stands now, without growth, Click's Lane will remain narrow with poor visibility and no sidewalks. With our citizens' input we can structure growth that we envision for our future. Please continue your positive input with your council representatives so that our children can enjoy the value of growing up in New Market.

DROUGHT WARNING ADVISORY

Reminder: The Virginia DEQ has declared a drought warning advisory for Shenandoah County, as well as surrounding areas. Please be mindful of water usage to help conserve water.

A drought *warning* advisory indicates a significant drought is imminent and is in effect for the Shenandoah region, which includes Augusta, Rockingham, Shenandoah, Frederick, Page, Warren, and Clarke counties, and for the Northern Virginia Region which includes Fauquier, Loudoun, Prince William, Arlington, and Fairfax counties.

Tips to help conserve water during a drought:

Refrain from cleaning the following:

- Vehicles including motorcycles, RVs, campers, golf carts, etc.
- Houses or other buildings
- Sidewalks, driveways and patios/decks

Reduce watering:

- Reduce lawn watering to 2 times or less per week between the hours of 9:00pm and 10:00am
- Reduce garden/flower bed, to include potted plants, watering only when needed between the hours of 9:00pm and 10:00am Refrain from planting new landscaping/grass

Limit showers to 5-10 minutes per person

Use dishwashers only when full
